## **Executive Summary**

This is the seventh annual report for the Midwifery Council of New Brunswick/Conseil de l'Ordre des sages-femmes du Nouveau-Brunswick (MCNB) and captures the work and activities of the Council between April 1<sup>st</sup>, 2022 – March 31<sup>st</sup>, 2023.

#### The primary activities of the MCNB were;

- Governance government appointed members and installation of a new Chair
- Continued involvement with the Canadian Midwifery Regulators Council (CMRC) and committees.
- Continued collaboration and engagement with the New Brunswick Health Professions Regulatory Network (NBPRN).
- Registration and renewal of registration of midwives.
- Policy Revisions

The Midwifery Council met 7 times this year. The Council meetings ran an average length of 88 minutes and included the Annual General Meeting in June 2022.

## **Activities of the Council**

#### Local/Provincial:

Ongoing awareness and discussions related to Indigenous Midwifery and focusing on the Truth and Reconciliation Commission recommendations as it pertains to Canadian midwifery regulators.

#### Governance activities:

- Installation of the new Chair and incoming two new government appointed Council members.
- Development of a performance review process for staff.

## Registration activities:

- Adoption of the new CMRC Self-Assessment Tool for reflective practice for midwives.

- Addressing the need for public education regarding regulated midwifery in the context of alternative care providers.

#### **Future Directions**

In September 2022, midwifery became regulated in PEI, the final province to attain regulation across Canada. This milestone shows that regulated midwifery continues to be relevant and in high demand.

With only 1 practice in the province located in Fredericton, regulated midwifery needs to become more accessible to the public across the province. By increasing midwifery positions and expanding service across NB, midwifery could be of greater assistance to our health care system as primary health care providers in both rural and urban communities thereby improving access to perinatal care.

In 2021, the Department of Health announced the evaluation of the Fredericton Midwifery Program via a third party, and this is in progress. A report was expected in mid-2022.

Revisions and amendments to the *Midwifery Act* are needed to support the delivery of regulated midwifery care within the province to best serve the public.

These include the need for more public members on Council, the ability to provide preceptorships for midwifery students, aligning midwifery practice to reflect the revised national CMRC competencies for entry-level practice, as well as further exploring additional competencies for expanding the scope of midwifery practice. Furthermore, creating access to midwifery education programs for New Brunswickers, the implementation of second attendants to attend births with midwives and allowing for Indigenous Midwifery by returning birth practices to Indigenous communities remain important aspects of the Council's work.

The Midwifery Council anxiously awaits the Review so that we can further focus our priorities.

## **Committees of the Midwifery Council**

#### **Therapeutics Committee:**

*Mandate:* The therapeutics committee makes recommendations on the following subjects:

- (a) the classification of drugs a midwife may prescribe and administer; and
- (b) the screening and diagnostic tests a midwife may order and interpret.

The committee met once on September 22<sup>nd</sup>, 2022. The committee updated its Terms of Reference and provided opinion on the mandatory inclusion of two advanced prescribing competencies for Hormonal Contraception and Sexually Transmitted Infections (STI) Management.

*Mandate:* To receive appeals from applicants denied registration and to make the final decision.

No requests were received. The committee did not need to convene this year.

#### **Complaints Committee:**

A roster of persons willing to serve on this committee and approved by Council, will be kept by the Registrar to ensure procedural fairness.

Mandate: A person may make a complaint in writing to the Registrar of a registered midwife. The Registrar shall refer the complaint to the Complaints Committee, if the conduct or actions complained of may constitute professional misconduct, incompetence, or incapacity. Section 39(3) Midwifery Act.

➤ No complaints received. The Complaints committee did not need to convene this year.

#### **Discipline Committee:**

A roster of persons willing to serve on this committee and approved by Council, will be kept by the Registrar to ensure procedural fairness.

The Discipline Committee may receive allegations from the Complaints committee. A hearing may be held. Direction would then be provided to the Registrar regarding the registered midwife's registration.

No complaints received, and the Discipline committee did not need to convene this year.

Notes to Compiled Financial Information

For the Year Ended March 31, 2023

#### 1. Purpose of the organization

The Midwifery Council was established as per the Midwifery Act. Its purpose is to regulate the practice of Registered Midwives in the province of New Brunswick The organization is registered as a not-for-profit organization under the Income Tax Act, and as such, is exempt from income taxes.

#### 2. Basis of accounting

The basis of accounting applied in the preparation of the statement of financial position of the Midwifery Council of New Brunswick/Conseil de l'Ordre des sages-femmes du Nouveau-Brunswick as at March 31, 2023 and the statements of operations and changes in net assets for the year then ended is the historical cost basis and reflects cash transactions with the addition of:

- Accounts receivable less an allowance for doubtful accounts;
- Property, plant and equipment recorded at historical cost and amortized on a declining balance basis:
- · Accounts payable and accrued liabilities;
- · Investments recorded at cost
- Prepaid expenses
